express our appreciation to those who have served this Community.




Just how much is this piling replacement project going cost the LPCA and why should I be required to pay for it?

This question has been asked about the private piling project and could be a myth in the making.

If you understand a little bit about how this Homeowner's Association operates, you know the answer. The short answer is, it will cost the LPCA nothing for Homeowner's private pilings.

Member dues go to maintain and improve Community property. The 145 canal lots with private docks are private property. All work done on those private canals is paid for by those property owners wishing to replace their pilings.

The Association is however proposing to replace the two pilings that support the Community boat ramp and will be paying the cost of those two pilings. These two pilings are estimated to be 47 years



old and since the cost to replace just two pilings at a later date would be astronomical, it seems prudent to replace these two pilings now while the mobilization costs can be shared with the private owners. The long answer is, nothing for private pilings but something for the two Community owned pilings.

THE RAT INVASION

To my fellow residents: Recently I have had to hire an exterminator to deal with an invasion of rats in our neighborhood and specifically under my house and he tells me I am not the only one who has recently called him from Lagoon Point. The first thing he asked me is if anyone is feeding the birds and when I told him yes, that some of the neighbors were throwing food into their yard to feed the birds, he said "then that's what is bringing them in".

Besides the potential health hazard, hiring an exterminator is not cheap and it is an expense that could be avoided. I have contacted members of the community to explain this problem and I have been met with little co-operation so I am pleading with everyone: Please **DO NOT FEED THE BIRDS**. Small particles of food falls between the rocks and that draws the rats and even if you are not yet having trouble with them, your neighbors are. Both table scraps thrown into the yard and bird seed dropped on the ground are problems.

Feeding wild animals (deer) and birds brings in all kinds of problems for your neighbors. Animals like racoons (that can be dangerous to our pets) are also drawn to people's yards when deer are being fed and they can be a serious nuisance. One of my neighbors is feeding the crows and seagulls off their back steps and not only do I now have rats but I also have large amounts of gulls and crows hanging out on my metal roof early in the morning waiting for their handouts. They are both messy and noisy in those numbers.

Please do the right thing and stop feeding wild birds and animals so that we may all live without the influx of these rodents and problems.

FOLLOW UP ON THE GREEN CRAB TRAPPING AT LAGOON POINT:

Volunteer monitors recently found one thing at Lagoon Point they hoped never to see – an invasive European green crab. The volunteers had been sampling for this crab since 2016 as part of Washington Sea Grant <u>Crab Team</u>. The crab they trapped in September was the first evidence that the globally-damaging invasive species had made it so far into the Salish Sea. Lagoon Point is one of six places green crab has been spotted along Washington's inland shores, which tells us we are on the leading edge of a potential invasion. Why are we worried? Green crab have a knack for becoming extremely abundant, and can dramatically alter local ecosystems. They can damage eelgrass beds, and eat the same types of seafood that we enjoy.

In response to this capture, Crab Team and Washington Department of Fish & Wildlife planned expanded assessment trapping. In early October, Crab Team staff and volunteers set 57 baited traps for two overnight soaks (see map). We are grateful to everyone who responded to our request to access your beach – your help made our work a great deal easier!

In addition to traps, we combed the shoreline for green crabs under rocks and as molted shells. **The only additional evidence of European green crab was one additional male crab captured at the north end of the lagoon lake.** We did capture (and release) a lot of cool native critters including eight species of native crab. The lagoon lake itself has a lot of healthy looking eelgrass in it, which supports a diverse ecological community. That there was so little evidence of green crab does not necessarily mean that we have eradicated

European green crab from Lagoon Point. But it does provide us with a sense that there is at least not a huge number of green crab there. The two found this year, and possibly others that have gone undetected so far, might have been the few very lucky survivors of a rare dispersal event.

It's often very difficult to be certain how green crab arrived in a new location. This species has a free-swimming life stage that can drift on currents, so it's possible they got washed into the lake through the tide gate from the large population just west of Victoria, BC. We can't rule out the potential that they were accidentally moved by humans, but it seems less likely in this case because there are no large boats or shellfish being moved into the lake.

Ongoing vigilance is critical at Lagoon Point, because trapping does not capture every single crab, and it's also possible that more larvae could be washed in. Volunteers will resume monitoring in April, when the crabs become active again. If green crab continue to pop up, or if they increase in numbers, a more aggressive response might be warranted.

Residents can help by training your eyes to recognize European green crab. It's not always easy - several native species of crab look similar to the invasive. **Color is not a distinguishing feature because the European green crab can be brown, red, orange or yellow, and a number of native crabs are green.** A few folks also have oyster bags hanging from docks. We saw a number of native kelp crabs, and some helmet crabs crawling on these bags, but it's possible green crab could end up on or in them. Look for a crab with a smooth shell, wider than it is long, and five spines to the outside of each eye.

Additionally, avoid potentially bringing green crab into Lagoon Point. Green crab can be moved on boats (in sea chests or bait lockers), or with shellfish. If you ever take your boat, or any of your gear (e.g., pots), to an area that has green crab, be very thorough in cleaning and inspecting for stowaways. Remember that it's also illegal to move any shellfish without a permit, even temporarily (e.g. wet storage off your boat). This is to reduce the chance of accidentally spreading invasive species and disease too.

If you ever suspect you have found a green crab, at Lagoon Point or anywhere else in Washington your explorations take you, please take several photos with something in the photo for scale, but leave the crab where it is. This sounds counterintuitive, but we want to make sure we don't accidentally harm native crabs. Email us at <u>crabteam@uw.edu</u> with the photos and location and we'll confirm the ID.


