As owners of property in Lagoon Point Subdivisions, 1,2,3,4 and Lagoon Point View Tracts, we are common owners of Lots A, B, C and D as described in the Plat of Lagoon Point.

The development, maintenance and upkeep of said Tracts are a joint obligation of all lot owners. Every lot owner within the Plat of Lagoon Point or Lagoon Point View Tracts is obligated to pay Lot Owner's Annual Fees on or before the first day of July each year, and Lot Owner's special assessments on or before the dates specified for the assessments. The Lot Owner's Annual Budget shall provide for the maintenance, upkeep and improvement of the Lagoon Point Common Areas.

As we plan ahead in 2014, we are mindful of gathering the community's input in regards to upcoming budgets and projects.

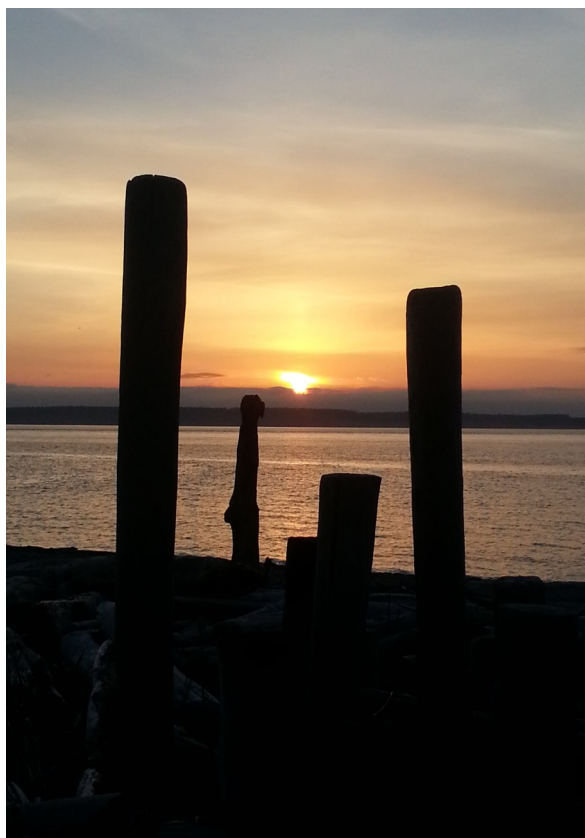
Envision the Future
