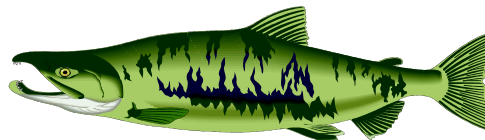

## **From the President – Bill Brown**

Contrary to the typo in the last newsletter, the Fishing Derby is on August 30<sup>th</sup>, the Saturday of Labor Day Weekend (See flier above.). Get your tickets, muster the kids and grandkids, catch fish and have fun. Special thanks go to Bill Schmid and Bob Vierra for, once again, taking the lead on this annual highlight of the Lagoon Point year. This time, Bill and Bob have tasked me with recruiting a new crew to take over the event next year. Carl Edelblute has graciously agreed to be part of this crew, but others are needed and welcome. Anyone interested should contact Bill or Bob or Carl to help (and understudy) this year.

We really do need Board members. Right now the offices of Assistant Secretary and Assistant Treasurer are vacant, and Areas 3 and 4 have no representative. All Board terms expire in December except those of the Area 2 and 6 Representatives. Some incumbents may stand for reelection, but others have served for a number of years and are looking forward to "retirement". Serving on the Board is really not a high anxiety pastime as, I understand, it once was. Since I joined the Board during Linda Armstrong's administration, we have experienced a cordial and cooperative atmosphere with mutual respect for differing views. I urge all to consider the call for candidates later in this newsletter. If we don't have enough volunteers to run the Association, we will have to consider hiring a management firm. This will be more costly and less friendly for all.

Thanks to Aaron Lowin's leadership, the permitting phase of our dredging project continues on track. It will likely require at least another year and more probably two or more before permits are issued. One question that remains open is the use of beach nourishment for disposition of the dredged material. To me it seems like a win-win situation for south beach owners and the community as a whole. The beach owners get a temporary reversal of the natural erosion process, and the community gets a lower cost per cubic yard dredged. So far, beach owner reaction has been understandably cautious, and we are proceeding with permits based on deep water disposal, not beach nourishment. Beach owners are strongly encouraged to further educate themselves on the issue, and to consider rebuilding their beaches while the opportunity is still open.

## Annual Meeting

## Architectural Committee Election

In accordance with the Lagoon Point Division 2-3-4 Covenants, a three-member Architectural Committee is established to implement and enforce those covenants. The duties consist mainly of reviewing and approving building plans for new homes and for major remodel projects to, ensure compliance with the covenants. ## Neighbor Aid Program

Many of you have donated to the Neighbor Aid Fund to assist other association members with their special dredging assessment payments. We truly thank those contributors. Those who want to apply for such assistance are reminded that we need a written request by the end of August. If you are on the County property tax relief program or would be, except for age or disability requirements, you are eligible for Neighbor Aid. Apply to Karen Edelblute or Bill Brown, or contact either of them with questions. All applications will remain confidential to all except the Treasurer and President.

## **Dredging Update – Aaron Lowin**

We continue to look into whether we can dispose of our dredging spoils by using ‘beach nourishment.’

With ‘beach nourishment’, the sediment from our dredging would be used to rebuild the eroded beaches along Oceanside Drive, that is, the west-facing beach properties along Admiralty Inlet along the southerly half of Lagoon Point. We think this is a win-win option. The South Beach property owners could have their eroded beaches rebuilt at community expense, and the dredging project could avoid the technical difficulties and high costs of barging out the dredge spoils and dumping the spoils somewhere in mid-Admiralty Inlet. Why dump the spoils if Lagoon Point property owners could use them?

To do beach nourishment, we would need the permissions of every South Beachfront property owner. We have had discussions with about half the 23 Division-2 South Beach property owners. If these meetings are successful, we will next invite the 16 Division-1 South Beach property owners.

In these discussions, we explain the beach nourishment option and ask the beachfront owners whether they would be agreeable to having their beaches rebuilt (at no expense to them) using the sediment dredged from our silting basin. We have posted on our LPCA website – [www.lagoonpoint.com](http://www.lagoonpoint.com) – a summary of the beach nourishment information we are providing the beachfront property owners. Go to the ‘News Flashes’ page and click on the Newsflash dated July 17, 2008.

Reaction of the Division-2 property owners has been mixed so far. Over the next several months, we intend to continue these discussions. If you are a South Beach property owner we urge you to come to one of our future meetings (not yet scheduled) and look into this option of having your beach rebuilt at our expense.

It will take some time to fully explore the beach nourishment option with the South Beach property owners. To avoid further delay, we will begin applying for dredging permits this fall, specifying that we would use open-water disposal for our dredge spoils. We are advised that since beach nourishment is ecologically advantageous and preferred by the permitting agencies, we could later switch our permit applications to that method without penalty.

## **Loose Dogs**

Area reps have received complaints of dogs running loose in the neighborhood. LPCA does not have authority to regulate pet control matters, but the Island County Code does cover this situation. Basically, dogs must not be allowed to go onto public property (roadways) or the private property of others unless controlled by a leash. The complete text of the county code is available on their website at [www.islandcounty.net](http://www.islandcounty.net). Questions and specific incidents should be taken up with County Animal Control at (360) 679-7398. Leave a message, and an animal control officer will get back to you.

While we are on the subject of dogs, please collect your dog’s droppings so they don’t foul the shoes or offend the sensibilities of your neighbors.

## Budget Ballot Passes

The June ballot on the 2008-2009 Budget passed 174.5 to 9, and the regular annual assessment remains at last year's level, \$120.00 per lot. Thanks for your support of our on going level of administrative and maintenance activity and accumulation of reserves.
